The Purchaser acknowledges and agrees that the sole obligations and responsibilities of the Escrow Agent shall be only those specifically provided in the Funeral Service Escrow Agreement. In the event Escrow Agent Resigns as Agent, Funeral Director, as trustee, will designate a successor Escrow Agent.

Revocation of this account may only be effected by a letter requesting such revocation, signed by the Purchaser or his or her legal representative and accompanied by a letter of acknowledgment signed by an official of The State of Connecticut Department of Social Services.
